



# Claremont 2008 Hazardous Waste Collection

The City of Claremont, the Upper Valley Lake Sunapee Regional Planning Commission, and the Town of Newport will provide FREE household hazardous waste collections for residents of Claremont.

## WHAT TO BRING:

Button, rechargeable, and ni-cad batteries; fluorescent light bulbs; household cleaners; polishes; hobby chemicals; pesticides and herbicides; flea powder; pool chemicals; oil-based paints (no latex); solvents; varnishes; stains; paint remover; mercury-containing devices such as thermometers; adhesives; driveway sealer; photo chemicals; and miscellaneous other materials which are considered hazardous as waste. Look on the product for the warning labels such as caution, flammable, reactive, caustic or poisonous.

## WHAT NOT TO BRING:

*Latex paint* is not considered hazardous, unless it is pre-1990 and labeled that it has mercury as a fungicide. Use kitty litter to dry out latex paint and then throw in your trash. It must be made into a solid to be considered solid waste. Empty, dry paint cans can be recycled at your recycling facility.

*Alkaline batteries* for flashlights and other household items are not considered hazardous and can be thrown in the trash. This includes most non-rechargeable batteries such as AA, AAA, C, D, and 9-volt batteries.

*Automotive batteries* can be exchanged, given, or even sold to local garages and auto parts stores. *Used motor oil* is collected at many town facilities or local garages.

Please do not bring *ammunition and explosives, fire extinguishers, radioactive materials, or propane tanks*. Contact your local police or fire departments about ammunition, explosives, and fire extinguishers. *Smoke and carbon monoxide detectors* can be sent back to the manufacturer. Propane tanks can be exchanged or refilled at a propane distributor.

## Businesses:

Are you a small business operating in the Upper Valley Lake Sunapee area? Small businesses are welcome and encouraged to participate but must register at least two weeks in advance and pay their disposal costs.
