

FACILITY RENTAL INFORMATION

The Claremont Savings Bank Community Center has excellent meeting room facilities and other amenities available for rental by the public. Packages are designed to offer a fun experience for family and friends.

RENTAL PROCEDURES/REGULATIONS

- Special Event/Conference Package rentals may incur staff costs for set-up and take down. All after-hour rentals also incur staff costs. After-hours begin at 9 p.m. on Monday–Thursday, 7 p.m. on Fridays, 6 p.m. on Saturdays & Sundays. Staff costs are \$18 per hour, per employee: minimum of one employee. Room layout change with less than 48 hours notice incurs \$50 labor charge.
- Kitchen is available for use by the group or a caterer. Kitchen is equipped with a refrigerator, ice maker, warming oven, microwave, and sinks. The kitchen is to be used for food service ONLY. No food preparation may be done on-site. A \$50 cleaning charge will be added to your fees if the kitchen is not left clean.
- Pool party package includes a 2-hour party room and pool use with access to the deck.
- Food and drinks are limited to the meeting rooms, game room, classrooms, kitchen and vending areas.
- CSBCC is a tobacco-free campus.
- Decorations are allowed on dining tables and buffet tables only. All decorations will be provided by the group. No decorations may be attached to the walls or ceilings of the facility. Archways or other backdrops must be free standing and may not be attached to the walls. Large banners or posters must be approved by facility management. Confetti or tape of any type is not allowed. Please ask the office if you have a specific request.
- All rentals must be requested at least 7 days in advance by completing a facility rental application and submitting a payment in full. Events cancelled less than 7 days in advance will forfeit the rental fee. The City of Claremont will submit a damage claim in the event of damage to the Community Center or its contents. The City of Claremont reserves the right to refuse any rental requests. Use that requires a fee by participants or is for-profit oriented in nature is discouraged.

RULES & REGULATIONS

- Every participant must have a pass or purchase a daily pass and must check in at the front desk upon entry.
- Non-members need day-use-pass for appropriate paid activities.
- Passes are available to both residents and non-residents.
- Proof of residency is required for Claremont residents.
- The fitness/cardio space is for patrons 12 and older.
- Participants 12–16 can use the fitness/cardio space, but must have completed the youth fitness training program.
- There will be limited hours of usage for youth ages.
- Children under the age of 10 must be accompanied by a person 16 years of age or older while in the facility.
- The CSBCC is a water-vending facility.
- Patrons who damage the facility or abuse its privileges, may forfeit the ability to use the Center without refund.
- Children 5 years and older must use gender appropriate locker room facility or please use family changing rooms.
