BLIND EXEMPTION

(RSA 72:37)

Filing Period: January 1st - April 15th

Current Exemption Amount: \$15,000 – Property Valuation Reduction

Qualifications:

- Every inhabitant who is legally blind as determined by the blind services program, bureau of vocational rehabilitation, department of education shall be exempt each year on the assessed value, for property tax purposes, of his/her residential real estate.
- Applicant must own residential real estate individually or jointly
- The exemption may be applied only to the residential real estate that is occupied as the principle place of abode by the Applicant

Please submit the following to the Assessing Office:

- ✓ Permanent Application form PA-29 (completed, signed and dated)
- ✓ Letter from NH Department of Education, Bureau of Services for Blind and Visually Impaired; stating the applicant is registered as Legally Blind
- ✓ Statement of Qualification form PA-33 (completed, signed and dated) if property is held in a Trust or Life Estate.
- ✓ Copy of the Trust Instrument as defined in RSA 564-B: 1-103(20) **OR** Certification of Trust prepared in accordance with RSA 564-B: 10-1013 if property is held in a Trust.
- ✓ Copy of the Deed showing the assigned ownership, if the property has a Life Estate.
